FEE RULES

- 1. An amount of Rs. 160,000 will be charged as 'Additional Security Refundable' to all Aitchison applicants for the year they are to apply for the Aitchison Entrance Examination. This amount will be adjusted in the last fee term i.e. April, May, June & July of the same Academic Year. Fee for the full Academic Year must be paid by all Aitchison applicants as per the schedule mentioned below, irrespective of the month of the Aitchison Entrance Examination or early withdrawal. In the event that any fee remains unpaid, LEARNING ALLIANCE will be unable to complete, stamp or submit the Aitchison College 'Attestation Form', and the Security Refundable, including the Additional Security of Rs. 160,000, will not be refunded.
- 2. In case of withdrawal, a written application must be officially received by the School Office.
- 3. The Security amount may be used for running expenditure; however, this amount will be refunded at the time of withdrawal.
- 4. Security Refund and School Leaving Certificate will be granted only if:
 - a) Full fee for the term during which the pupil leaves has been paid
 - b) The parent has completed and submitted all withdrawal documents at least one month before the end of last paid fee term
 - c) All outstanding fee and fines including any damage to school property have been paid in full
 - d) The refund is claimed within six months from the date of withdrawal
