Learning Alliance and Learning Alliance International DHA offer generous Merit scholarships to our students of Class VII – A2 in **CAIE** & MYP I – DP 2 in **IB**, and co-curricular scholarships to our students of Class VI – A2 in **CAIE** & MYP I – DP 2 in **IB**. The analysis of student performance is carried out on the basis of their academic/co-curricular achievements.

In the case of students receiving multiple scholarship offers/fee discounts, the one with the higher waiver will be applicable. Furthermore, unforeseen circumstances that result in a School-wide fee reduction will make the scholarship null for that period of time. Students may be issued the full August – September fee bill, and once the scholarship is awarded, allotted amount is adjusted in the October-December fee bill.

Any scholarship, whether academic or co-curricular, is non-transferrable, and will not be valid in case of inter-campus transfers. Students who are awarded scholarships must be vigilant regarding their attendance and discipline in order to maintain the scholarship.

ACADEMIC SCHOLARSHIPS - CAIE Abdul Salam Mehta Scholarship

The Abdul Salam Mehta (ASM) Scholarship is awarded to the best students in OIII in two categories; one from the Science stream and the other from the Humanities stream. The O Level Academic Results of three years are accumulated, and the 100% tuition fee and other charges waiver is offered for a complete two years of the A Level Programme.

Students who are awarded the **Abdul Salam Mehta (ASM) Scholarship** must maintain good attendance and discipline as well as a 'B' grade, in three subjects and at least a pass in the fourth subject in the internal A-I Final Examinations/CAIE AS Examinations. In the event that the scholarship is withdrawn from the student it will not be awarded to another student.

Merit Scholarships – Class VII – OIII

One merit scholarship of 25% is awarded on the tuition fee to the **top performing student** in each year group from Class VII – OI, based on the student's cumulative performance, based on their monthly tests, Mid-Year and Final Examinations in the previous year. The scholarship is valid for one academic year.

Two merit scholarships of 25% from each year group are awarded on the tuition fee to the Proclamation gold medal holders of Science and Humanities stream in OII and OIII. The scholarship is based on the student's cumulative performance in the previous year, and is valid for one academic year.



Merit Scholarships – A LEVEL

Learning Alliance A Level Programme offers merit scholarships to motivate students who have evidence of academic achievement in the CAIE O Level Examination. A-I scholarships are reviewed at the end of the academic year and may be continued in A-II based on the CAIE AS Level result.

Students receiving an merit scholarship in A levels are ineligible for the Child Fee Discount.

A-I Scholarships:

The AI Scholarships range from a financial waiver of 25% to 100% based on the students' grades, the details of which are given in the table below:

A1 Scholarships will be awarded to students in the same year preceding the publication of their O-Level results. Students who have taken a gap year after O-Level or are repeating A1 are not eligible for A1 scholarships. **Students cannot add retaken subjects to increase their scholarship allotment.**

To be eligible for a scholarship, students must achieve grades in subjects that they have officially registered for with the school. Any subjects pursued independently / privately will not be taken into account for scholarship evaluation.

A-II Scholarships:

The scholarship awarded in A-II is based on student performance in the best of three subjects. However, students must maintain at least a 'D' or above in their fourth subject. Students are issued the full August – September fee bill, the scholarship is then adjusted in the October-December fee bill. Once the award has been allotted the amount paid for August- September is adjusted.

For students taking only three subjects, Urdu will not be considered for a scholarship award unless taken as a CAIE Examination in A-I registered through the school. The CAIE grade in Urdu as a fourth subject may also be considered.

Students will not be awarded scholarships if, for any reason, they sit for internal Examinations in A1 and choose not to appear for the AS CAIE's.

The School Board shall evaluate all scholarship applications and allot them to deserving students. The School Board reviews attendance, discipline and academic history when allotting these scholarships.



International Baccalaureate Naim Salam Mehta Scholarship

The Naim Salam Mehta (NSM) Scholarship is an academic award for the duration of two years awarded to the highest scorer in the MYP V e-Assessments. Students must ensure a good attendance and discipline as well as a 'level 6' in all 6 subjects and a Grade B in Core while in the Diploma Programme in order to maintain the scholarship. This 100% tuition fee waiver is on the current tuition fee and other charges for the IB Diploma Programme.

Merit Scholarships – IB MYP I-IV

A merit scholarship of 25% off the tuition fee is awarded to the Students of the Year (a title awarded to students demonstrating outstanding academic and co-curricular performance) of MYP I-IV. The scholarship is based on the student's cumulative performance in the previous year and is awarded to the student with the highest Level of Achievement in each year group and is valid for one academic year only.

Merit Scholarship – Diploma Programme

Learning Alliance International Diploma Programme offers a merit scholarship to motivate students who have evidence of academic achievement in the MYP V e-Assessment/Olevel/SSC/Matriculation. Students receiving a merit scholarship in the Diploma Programme are not eligible for any other Fee Discount.

The DP1 Scholarship will be awarded to students in the same year preceding the publication of their MYP V e-Assessment results. ***Students cannot add retaken subjects to increase their scholarship allotment.***

The DP II Scholarship will be awarded to students in the same year preceding the publication of their DP I result. ***Retaken subjects cannot be included to increase the scholarship allotment.***

The Scholarship awarded in DP II is based on student performance in the best of six subjects and the Core in the DP I final examinations. Scholarships will be awarded according to the total points attained however, a scholarship will not be awarded if there is a 'level 3' or 'C' in the result.

Students are issued a bill for the full fee for August – September. The scholarship amount is allocated in the fee bill for October to December, which includes any adjustments made for the scholarship amount already paid.

The School Board shall evaluate all scholarship applications and allot them to deserving students. The School Board reviews attendance, discipline and academic history when allotting these scholarships.



CO-CURRICULAR SCHOLARSHIPS

In order to motivate students to not only maintain a healthy balance between academics and co-curricular activities, but also to strive towards improving their skills and expertise, Learning Alliance and Learning Alliance International may offer a co-curricular scholarship for students of Class VI-A2 in **CAIE** & MYP I-DP 2 in **IB**.

Students of Class I-V in CAIE & PYP I-V in IB may be eligible for a 25% co-curricular scholarship on the tuition fee if they have displayed exceptional performance in a co-curricular activity and represented the school as a **Pakistan blazer holder** on a renowned and prestigious national/international forum.

In the case of students receiving both academic and co-curricular scholarship offers, the one with the higher waiver will be applicable. Additionally, students already receiving any kind of other fee discounts are not eligible for the academic and co-curricular scholarships. Furthermore, unforeseen circumstances that result in a School-wide fee reduction will make the scholarship null for that period of time. Scholarships are non-transferrable, and will not be valid in case of inter-campus transfers.

Students may be issued the full August – September fee bill, and once the scholarship is awarded, allotted amount is adjusted in the October-December fee bill.

Students who have received a written disciplinary warning in the previous academic year are not eligible to apply. They are also required to maintain minimum passing marks in their academics to continue their scholarship throughout the year.

Policy

- The co-curricular scholarship may be awarded based on the student's exceptional performance and expertise in national and international co-curricular competitions in sports, debates, and various other categories.
- Proof of active and consistent participation in co-curricular activities for a minimum of 3 years must be provided by the student at the School Board's instruction.
- The decision is made at the School Board's discretion. The decision is final and cannot be contested.
- There is no fixed quota of scholarships awarded in this category.
- The scholarship is valid for one academic year only.
- To maintain the awarded scholarships in the subsequent year, the student's profile will be reviewed, keeping in mind the student's recent and continuous achievements.
- Since the students must meet minimum criteria set by the School Board, there may be instances where no students are awarded the co-curricular scholarship in a particular academic year.
- Students who are awarded scholarships must maintain good attendance and discipline.
- Student who are awarded scholarships for sports or any activity that requires the student to travel for tournaments and similar events, leaves and academic results will be accommodated as per the School Board's discretion.
- **For A LEVEL students:** Students who are awarded scholarships must maintain a 'C' grade, in three subjects and at least a pass in the fourth subject in the internal A-I Final Examinations/CAIE AS Examinations.



- **For DP students:** Students who are awarded scholarships in the DP must maintain a minimum level '4', in all the six subjects of DP-I Final Examinations.
