



## **SCHOLARSHIPS LEARNING ALLIANCE AZIZ AVENUE CAMPUS**

Learning Alliance Aziz Avenue offers generous academic scholarships to our students of Class VII – OIII, and co-curricular scholarships to our students of Class VI – OIII. The analysis of student performance is carried out on the basis of their academic/co-curricular achievements.

In the case of students receiving multiple scholarship offers/fee discounts, they must pick the one offering the higher waiver. Furthermore, unforeseen circumstances that result in a School-wide fee reduction will make the scholarship null for that period of time. Students may be issued the full August – September fee bill, and once the scholarship is awarded, allotted amount is adjusted in the October-December fee bill.

Any scholarship, whether academic or co-curricular, is non-transferrable. Students who are awarded scholarships must be vigilant regarding their attendance and discipline in order to maintain the scholarship.

### **ACADEMIC SCHOLARSHIPS - CAIE**

#### **Abdul Salam Mehta Scholarship**

The Abdul Salam Mehta (ASM) Scholarship is awarded to the best students in OIII (one award is for Science Students and the other for Humanities students) **should they choose to transfer to DHA for their A levels.** O Level Academic Results of three years are accumulated and the 100% Tuition Fee waiver is offered for two years of A Level Programme.

#### **Merit Scholarships – Class VII-VIII**

An academic scholarship of 25% is awarded to the Proclamation gold medal holders in Class VII and VIII. The scholarship is based on the student's cumulative performance in the previous year, and is valid for one academic year.



## Merit Scholarships – O Level

Learning Alliance is re-introducing a scholarship policy to motivate students who show evidence of academic achievement. The scholarship criterion for the award is based on the cumulative average of the year end result of the previous year and is valid for one academic year.

### **Scholarships for OI**

For students of OI, Learning Alliance is providing the following merit scholarships:

1. An academic scholarship of 25% is awarded to the Proclamation gold medal holders in OI. The scholarship is based on the student's cumulative performance in the previous year, and is valid for one academic year.
2. If a student is not a gold medal holder, but secures the following percentages in their cumulative average in the previous year, they are eligible for the following merit scholarship:

Scholarship Award	Criterion
25% off on Tuition Fee	75% cumulative average on Class 8 result
50% off on Tuition Fee	80% cumulative average on Class 8 result

If a student is eligible for both the scholarships, the one with the higher waiver will be applicable.

### **Scholarships for OII-OIII**

For students of OII-OIII, Learning Alliance is providing the following merit scholarships:

1. An academic scholarship of 25% is awarded to the Proclamation gold medal holders in OII-OIII. The scholarship is based on the student's cumulative performance in the previous year, and is valid for one academic year.
2. If a student is not a gold medal holder, but secures the following percentages in their cumulative average in the previous year, they are eligible for the following merit scholarship:

Award	Scholarship Criterion
25% off on Tuition Fee	75% cumulative average on previous class result
50% off on Tuition Fee	80% cumulative average on previous class result



If a student is eligible for both the scholarships, the one with the higher waiver will be applicable.

All scholarships are valid for one year. The School Board shall evaluate all scholarships and allot them to deserving students. The School Board reviews attendance, discipline and academic history when allotting these scholarships.



## Merit Scholarships A LEVEL – For Students Transferring to DHA

Learning Alliance A Level Programme offers an academic scholarship for students choosing to transfer to DHA for their A Level, in order to motivate students who have evidence of academic achievement in the CAIE O Level Examination. The student transferring to DHA from Aziz Avenue will also be facilitated so that they do not pay the difference in Security when joining the A Level Programme. A-I scholarships are reviewed at the end of the academic year and may be continued in All based on the CAIE AS Level result.

Students receiving an academic scholarship in A levels are ineligible for the Child Fee Discount.

### A-I Scholarships:

The AI Scholarships range from a financial waiver of 25% to 100% based on the students' grades, the details of which are given in the table below:

Scholarship Award	Criterion
100% off on Tuition Fee & other charges	10 As or above
100% off on Tuition Fee	8 As or above
75% off on Tuition Fee	7 As
50% off on Tuition Fee	6 As
25% off on Tuition Fee	5 As

*Lab charges will apply (if any)*

### A-II Scholarships:

Award	Scholarship Criterion
100% off on Tuition Fee	3 As and above
75% off on Tuition Fee	2 As and 1 B
50% off on Tuition Fee	1 A and 2 B's
25% off on Tuition Fee	3 B's

*Lab charges will apply (if any)*



## CO-CURRICULAR SCHOLARSHIPS

In order to motivate students to not only maintain a healthy balance between academics and co-curricular activities, but also to strive towards improving their skills and expertise, Learning Alliance has a co-curricular scholarship for students of Class VI-A2 in **CAIE**.

In the case of students receiving both academic and co-curricular scholarship offers, the one with the higher waiver will be applicable. Additionally, students already receiving any kind of other fee discounts are not eligible for the academic and co-curricular scholarships. Furthermore, unforeseen circumstances that result in a School-wide fee reduction will make the scholarship null for that period of time.

Students may be issued the full August – September fee bill, and once the scholarship is awarded, allotted amount is adjusted in the October-December fee bill.

Students who have received a written disciplinary warning in the previous academic year are not eligible to apply. They are also required to maintain minimum passing marks in their academics to continue their scholarship throughout the year.

### Policy

- The co-curricular scholarship is awarded based on the student's performance in national and international competitions in various categories
- The decision is made at the School Board's discretion on voting basis. The decision is final and cannot be contested
- There is no fixed quota of scholarships awarded in this category
- The recipient of the scholarship receives a 25% waiver on their tuition fee
- The scholarship is valid for one academic year only.
- The awarded scholarships will be reviewed in the upcoming academic year, keeping in mind the student's recent and continuous achievements
- Since the students have to meet a minimum criteria set by the School Board, there may be instances where no students are awarded the co-curricular scholarship in a particular academic year
- For students who are awarded scholarships for sports or any such activity that requires the student to travel for tournaments and similar events, leaves and academic results will be accommodated as per the School Board's discretion

### Co-curricular Categories

***Note: This is to act as a guide for the method through which the co-curricular scholarship applications will be analysed. It covers guidelines for student achievements in various fields; however additions to this can be made according to the growing areas in which our students have proven their expertise. The scale and impact of the activity is to be awarded according to the School Board's discretion.***



- **Sports and Debates**

The evaluation of candidates with achievements in sports and debates will be analysed according to their consistency in performance at the national and international level competitions and tournaments.

- **Social and Entrepreneurial Initiatives**

Students actively working towards the betterment of society or the environment are also eligible for the co-curricular scholarship, as it depicts their drive to contribute to the wellbeing of others. This may be done through entrepreneurial ventures (e.g. Charity drives, NGOs) or establishing an online platform through which they spread a positive message. Applications belonging to this category will be analysed by the School Board according to the nature and impact of the initiative.

- **Performing & Visual Arts**

Student achievements belonging to this category will be analysed on the basis of their talent and drive towards becoming an expert in the performing arts. The School Board will analyse and evaluate the students on the basis of dramatics, dance, music, or art & design competitions the student has been a part of (and won), their performance in the media or on an online platform.

- **Creative Writing and Journalism**

Students with achievements in creative writing and journalism are also eligible for the co-curricular scholarship and will be analysed according to the consistent impact and influence that the child is able to achieve. This can be done in the form of writing competitions, online publications, or printed material.
